- When using descriptions and/or images from the archives to illustrate your research, etc. please give consideration not to infringe on privacy, portrait rights, and/or cultural sensitivity.
- When publishing research results, please mention the archives name (source), archives number, etc. of the "Ethnology Research Archives of the National Museum of Ethnology" as references.
- 7. Please send a copy of your publication (in the form of books, academic papers, articles, etc.) to the department in charge.
- When research results are published online, presented at seminar meetings, exhibitions, other events, or

broadcasted, please report the details to the department in charge.
